

# BACHELOR OF SCIENCE IN EXCEPTIONAL STUDENT EDUCATION[1]

## Program Description

Graduates of the program will be prepared to teach and support students with varying learning needs in K–12 settings. Upon successful completion of all program coursework and the required FTCE assessments, graduates will be eligible for the appropriate Florida certification and endorsements. The program has been submitted for approval as an Initial Teacher Preparation (ITP) program with the Florida Department of Education's Bureau of Educator Recruitment, Development, and Retention (BERDR), and approval is anticipated prior to the program's August 2026 start.

The program will start its first cohort in August 2026 (Fall 2026). Students may apply in the meantime and explore options to complete coursework leading up to Fall 2026.

The Bachelor of Science in Exceptional Student Education (BSESE) degree at Lake-Sumter State College (LSSC) provides a high-quality education for students in preparation for teacher certification in Exceptional Student Education (Grades K-12) with endorsements in Reading (K-12) and English for Speakers of Other Languages (ESOL, K-12). Through impactful, school-based experiences embedded throughout related coursework, LSSC prepares teacher candidates for the realistic demands of today's classrooms while meeting the needs of school districts throughout Central Florida. Program graduates are eligible to obtain Exceptional Student Education (Grades K-12) Certification through application to the Florida Department of Education.

## Bachelor of Science in Exceptional Student Education End-of-Program Student Learning Outcomes

Job placement rate: Benchmark: 95% of Exceptional Student Education BS program graduates will be employed full-time or part-time in a teaching position within six months of graduation.
